## **Shin splint anatomy and treatment - Chiropractic Economics**

These extraspinal changes consist of hyperostosis at sites of tendon and ligament attachment to bone, para-articular osteophytes, and ligament ossification. Generally in the peripheral skeleton, periosteal spurs arising at the site of osseous attachment of the tendon are more prominent than true calcification of the tendon itself.
